14.115 Resolved that the Minutes be approved and signed by the Chairman as a correct record.

14.116 None

RESIDENTS' ISSUES

14.117 A resident asked a question of the future of the Carmelite Monastery/land in Green Lane and a lengthy discussion took place. Cllr Sims reported that the Parish Council had not been informed of any developments. She reported that the nuns would leave by the end of the month and trees in the grounds should be protected by the following day. There should also be a management plan developed with the protection of the trees which would include a survey. Cllr Sims reassured residents that if any planning applications were received by the Parish Council that would affect residents, they would be informed immediately by the Parish Council.

A resident raised a question of the future of land along Ecclesfield Road. Cllr Sims replied that the land was green belt. Although there was some interest shown in the land by developers at present, the green belt status had not been relaxed.

A resident raised concerns over the amount of litter accumulating around the shops on Walmesley Road and overflowing bins. Cllr Sims replied that the bins were on a 3 weekly schedule to be emptied. Cllrs would ask if the schedule could be improved.

All residents left the meeting.

POLICE REPORT

14.118 No one from the police was able to attend. PCSO McManus sent a report with the Crime Statistics compared to the same period last year. A discussion took place regarding the increase in burglaries this year. Cllr Sims reported that the Councillor Improvement Fund was paying for a metal fence to be installed at Foxwoods after a resident's rear fence panels were removed and set on fire.

BUDGET FOR 2014/15

14.119 The budget was approved and it was resolved that a precept of £53,936 for 2015/16 be requested which results in a cost to residents of £14.19 – same as last year.

REPORTS

14.120 Resolved to note the following:

<u>Smithy Working Party</u> – all Councillors were given a copy of the Curators' Report for February. The following points were discussed:

- Vintage Valentine's Victorian cards on loan from The Atkinson now on display in Smithy along with cards from the Smithy's collection. St Helens Star were interested in the exhibition and took photographs which should feature in the next issue.
- Murder Mystery Evening all tickets were sold for the event on 14 February 2015. An event licence had been purchased
- Smithy building Vicky reported that the doors to the Smithy were becoming increasingly difficult to align with the bolt holes to keep them open. Clerk to contact Metalcraft to update the quote for a metal frame to hang the doors
- Man's Best Friend Curators had been identifying items for display along with publicising the event through contacts

<u>Finance Sub</u> – Cllrs Sims, Almond, Duncan, G Pearl and Skepper along with the Clerk met on Monday 26 January at 10am to discuss the budget and proposed precept (See Item 14.119).

Ecclesfield — Cllrs Sims and Haw along with the Clerk attended a site visit to Ecclesfield with John Boden, St Helens Council on Tuesday 27 January at 10am to discuss the request from Bleak Hill Rovers for a new mini pitch behind houses on Broadway. After looking at the site and considering measurements, John advised that this would be too close to houses on Broadway. Also the condition of the ground was unsuitable and liable to flooding. He did not recommend the pitch be marked out.
