Cllr Sims suggested that maybe after elections in May 2022, the website could be addressed. In the meantime, the Clerk would upload a document entitled 'Becoming a Parish Councillor' to the website. Also, Cllr Ashcroft suggested residents should attend meetings to observe proceedings.
